# **NCTracks Crash Course Kit for Providers**

The Crash Course Kit is intended to meet the short-term needs of providers who are either unaware of NCTracks, did not participate in any NCTracks training activities or experienced technical difficulties accessing NCTracks training content. The kit is designed to insure you understand what NCTracks is, how NCTracks will benefit providers, the checklist of things you need to do to participate in NCTracks and how to get trained in the use of NCTracks.

## Will there be training opportunities for providers after go-live?

Yes. All training opportunities will be announced through the NCTracks provider portal after July 1<sup>st</sup>. All recorded Instructor Led class recordings will be available, all eLearning Computer Based Training BTs will remain available, and other training activities will be published in the portal. # NCTracks Provider Claims and Billing Assistance Seminars

Good news! The new NCTracks portal is almost here!

Providers will have greater visibility with quick and easy access to:

- View claims status in real time
- Update/edit provider records
- Request/confirm prior approval
- Retrieve historical remittance advices for up to seven years
- Verify recipient eligibility

We want to ensure all providers have an understanding of how the provider enrollment and claims process works within the new NCTracks.

NCTracks Provider Claims and Billing Assistance Seminars will be held in six locations across North Carolina from **July 16<sup>th</sup> through August 1, 2013** to answer frequently asked questions and concerns such as:

## **Enrollment**

- What is an NCID and how do I obtain an NCID?
- As a currently enrolled provider (CEP) will I be required to complete a new or additional enrollment application?
- How will I be notified once I am enrolled?

### CCNC/CA

- How should claims be filed when a PCP refers a CA Enrollee to our provider office?
- How can I tell if a patient is enrolled with Carolina ACCESS?
- Can referrals be made by telephone and online?

# **Prior Approval (PA)**

- What services require prior approval?
- How will I know if additional information is required for a prior approval request?
- How do I check the status of my PA requests submitted to other vendors such as MedSolutions?
- What is the turnaround time for PA requests?

## Claims, Adjustments and Overrides

- How do I resolve my denied claims?
- Can I check claim payment status online?
- How do I submit an adjustment request?
- How do I submit a time limit, third party, or Medicare override?
- What if the patient has a Third Party Insurance?
- Who do I contact for additional questions or information?

The <u>NCTracks Provider Claims and Billing Assistance Guide</u> will be the primary document referenced during the seminar. Copies will be provided at the seminar. Pre-registration is required and seating is limited. Unregistered providers are welcome to attend, if space is available.

The seminar will begin at 9:00 a.m. and end at 4:00 pm. Providers are encouraged to arrive by 8:45 a.m. to complete registration. Lunch will not be provided; however, there will be a lunch break. **Because meeting room temperatures vary, dressing in layers is advised.**
